## 2. Public Comment

Absent permission from the Mayor, all speakers must remain at the podium. Any speaker that engages in personal attacks and/or acts in an uncivil manner will be stopped and may be prohibited from future opportunities to publicly address the Council. The Mayor, Clerk-Treasurer, City Council members, and City staff are available after the meeting for questions and more extended discussions.
