May 24, 2016

The Board of Directors of the Valparaiso City Utilities met at the Valparaiso City Utilities Board Room, 205 Billings Street, Valparaiso, Indiana on Tuesday, May 24, 2016 at 5:00 P.M. Board Members present were: President Dave Bengs, Vice President Mike Sur, Asst. Secretary Kurt Minko, and Treasurer Mark Thiros. Also present were Attorney Mike Langer, Environmental Compliance Administrator Ed Pilarski, Controller Alina Hahn, Exec. Admin. - The minutes of the May 10, 2016 meeting were reviewed and approved.
- The Board reviewed and approved the submitted claims.
- Alina Hahn presented the April 2016 Financials which were approved.
- Shihua Chen presented the Wellhead Protection Phase I and 5 Year Update Recommendation. Boyd Asphalt, Inc. \$11,180.00 Indiana Asphalt No bid received Site Services \$27,734.00

Paul recommended acceptance of the bid from Boyd Asphalt, Inc. in the amount of \$11,180. This has been budgeted in the 2016 capital improvement plan. The board approved the bid received from Boyd Asphalt.
