**ORDINANCE No. 27-2010**

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, AMENDING CHAPTER 74 OF THE CODE OF ORDINANCES ENTITLED "PARKING SCHEDULES"**

WHEREAS, Chapter 74 of the Code of Ordinances sets forth the location of no parking and parking meter zones within the City of Valparaiso, Indiana; and

WHEREAS, the Common Council is desirous of amending Chapter 74 of the Code of Ordinances to update the location of parking permit and metered zones within the City.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Valparaiso, Indiana, that certain sections of Chapter 74 of the Code of Ordinances shall be amended to read as follows:

**SCHEDULE II. PARKING METER ZONES.**

(A) The following designated streets or parts of streets are hereby declared to be parking meter zones.

(B) Parking at metered spaces shall be subject to the provisions of Chapter 72.

**SCHEDULE III. PARKING PERMIT ZONES**

(A) The following designated municipally owned or operated parking lots are hereby declared to be parking permit zones.

1. The city parking lot on the south side of Chicago Street between Lafayette Street and Napoleon Street
2. The city parking lot at the northwest corner of Jefferson Street and Washington Street
3. The city parking lot on the northwest corner of Jefferson Street and Lafayette Street
4. The city parking lot at the southwest corner of Jefferson Street and Morgan Boulevard
5. The city parking lot at the northeast corner of Lincolnway and Michigan Street
6. The city parking lot at the southeast corner of Indiana Avenue and Lafayette Street
7. The city parking lot at the southwest corner of Monroe Street and Franklin Street
8. The city parking lot located on the southeast corner of Jefferson Street and Napoleon Street
9. The parking lot located on the southeast corner of Indiana Avenue and Michigan Street.


(B) Parking permit spaces shall be subject to the provisions of Chapter 72.

BE IT ORDAINED THAT, if any portion of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other portion or provision of this Ordinance.

BE IT FURTHER ORDAINED THAT, all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. It is provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinances or parts of ordinances are hereby ratified, re-established and confirmed.

This Ordinance shall be in full force and effect from and after its adoption and the procedures required by law.

**PASSED** by the Common Council of the city of Valparaiso, Indiana, by a 4-2 vote of all members present and voting this 23<sup>rd</sup> day of August, 2010.


