RESOLUTION #45, 2015

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, RATIFYING THE EXECUTIVE ORDER OF THE MAYOR OF THE CITY OF VALPARAISO, INDIANA, ADOPTING A CAPITAL IMPROVEMENT PLAN SPECIFYING THE USES OF THE REVENUE RECEIVED FROM THE CERTIFIED DISTRIBUTIONS OF COUNTY ECONOMIC DEVELOPMENT INCOME TAX ("CEDIT") FUNDS IN FISCAL YEARS 2016 AND 2017 AND DESIGNATING THE RECIPIENT(S) OF SAID FUNDS

WHEREAS, Ind. Code § 6-3.5-7, *et seq.*, requires the executive of a city to adopt a capital improvement plan specifying the uses of CEDIT funds and designating the recipient(s) of said funds; and

WHEREAS, in conformance with the requirements of I.C. 6-3.5-7, *et seq.*, the Mayor of the City of Valparaiso, Indiana, has issued an Executive Order ("Order") Adopting a Capital Improvement Plan Specifying the Uses of the Revenue Received from CEDIT Funds in Fiscal Years 2016 and 2017 and Designating the Recipient(s) of said funds. The Order is attached hereto, incorporated herein and marked as *Exhibit "A"*; and

WHEREAS, the Common Council of the City of Valparaiso, Indiana, is desirous of approving this Resolution in order to ratify the Mayor's Order and adopt the Capital Improvement Plan for CEDIT funds in Fiscal Years 2016 and 2017 and designation of the recipient of said funds.

THEREFORE BE IT RESOLVED by the Common Council of the City of Valparaiso, Indiana, that the Mayor's Order is hereby ratified and the Capital Improvement Plan for CEDIT funds in Fiscal Years 2016 and 2017 and the designation of the recipient of said funds is adopted.

THEREFORE BE IT FURTHER RESOLVED by the Common Council of the City of Valparaiso, Indiana, that the CEDIT funds in Fiscal Year 2016 is budgeted in the Capital Improvement Plan as follows:
