

# CITY OF VALPARAISO HUMAN RIGHTS ORDINANCE

Frequently Asked Questions

## What is the Human Rights Ordinance (HRO)?

• It is a local civil rights law that offers all of Valparaiso's citizens a local and accessible option for pursuing a remedy should they experience discrimination where they shop, eat, work, learn or reside.

### Why was the HRO enacted?

The City of Valparaiso strives to maintain and encourage a civic environment that is welcoming
and inclusive to all people. Valparaiso stands for the principles of freedom and equal
opportunity. The HRO established a meaningful process that offers the opportunity for the City
to investigate inappropriate acts and to foster conversation, understanding and reconciliation
between parties.

#### How did the HRO become enacted?

• The Human Relations Council (HRC) was established in 2011 to advise the mayor on issues of diversity, equity and inclusion. The HRC spearheaded the efforts to enact the HRO and voted to recommend passage of the HRO to the Valparaiso City Council. The Council passed the HRO which the mayor signed into law on May 25, 2016. #### How is the HRO enforced?

The Valparaiso City Council established the Investigation and Reconciliation Committee (IRC)
to ensure that discrimination claims are investigated and decided upon in a timely manner. The
IRC consists of five (5) Valparaiso residents who decide each case by a majority decision.

### How do you file a complaint?

A complaint may be filed at no cost with the City's Clerk - Treasurer Office.
 The complaint must be filed within sixty (60) days of the alleged HRO violation.

## What are the potential outcomes for a case filed under the HRO?

For each properly filed complaint, the IRC Committee meets and decides each case by a
majority decision. The Ordinance seeks to resolve disputes between parties by offering
mediation services. The IRC may also assess fines up to \$500 against the offending party.

# Are there any exceptions to the protections of the HRO?

Yes, there are certain exceptions which the protections of the HRO do not apply to. For
example, there are religious exceptions for churches and associations organized for primarily
religious purposes. There are also exceptions for age discrimination in regards to housing that is
established and operated primarily for senior citizens.
