PROJECT DESCRIPTION:

IRC Valparaiso Walk LLC, owner of the existing Valparaiso Walk Shopping Center, is proposing to subdivide the center into four (4) distinct lots. Lot lines have been drawn to follow existing lease lines and the curbs surrounding the relocated access drive, recently completed by the City.

Lot 1 will be the anchor lot, encompassing the strip mall at the rear of the property. This lot will be approximately 13.25 acres, with 127,646 SF of building space and 619 parking spaces. The lot will provide a landscape space ratio of 0.19 and a parking ratio of 4.85 spaces/1,000 SF.

Lot 2 will be at the northwest corner of the property, between the Aldi access drive and shopping center access drive. Lot 2 is currently occupied by parking area, but is proposed to be developed as a restaurant with drive-thru use. This lot will be approximately 1.14 acres, with 4,990 SF of building space and 49 parking spaces. The lot will provide a landscape ratio of 0.19 and a parking ratio of 9.82 space/1,000 SF. Approvals for this development will follow in a separate application.

Lot 3 will be along the center of the frontage, encompassing the existing strip mall along Silhavy Road. This lot will be approximately 1.69 acres, with 12,742 SF of building space and 117 parking spaces. The lot will provide a landscape space ratio of 0.14 and a parking ratio of 9.18 spaces/1,000 SF.

Lot 4 will be at the southwest corner of the property, encompassing the existing T.G.I. Friday's restaurant. This lot will be approximately 0.81 acres, with 5,145 SF of building space and 36 parking spaces. The lot will provide a landscape space ratio of 0.33 and a parking ratio of 7.00 spaces/1,000 SF.

The existing shopping center was approved by the Valparaiso Board of Zoning appeals in 2003 and reapproved in 2006 for the T.G.I. Friday's development. The BZA approved a maximum site coverage of 82% (landscape space ratio of 18% minimum) and an overall parking count of 845 spaces. The overall shopping center (after Lot 2 development) will provide a landscape space ratio of 0.19 and 821 parking spaces. The center meets the approved landscape space ratio but is short of the parking count by 24 spaces. The owner states that the lack of 24 spaces shall not cause undue hardship on shoppers, as there are cross-access and cross-parking agreements in place, and the center is composed of complimentary uses.

RECITALS

WHEREAS, Menard and IRC's predecessor in interest, IBT Valparaiso LLC, an illinois limited liability company, entered into that certain Declaration of Reciprocal Easements and Restrictive Covenants dated as of January 27, 2004, and recorded in the Porter County Recorder's Office in Porter Count, Indiana on February 6, 2004 as Document No. 2004-003975 (the "Declaration");

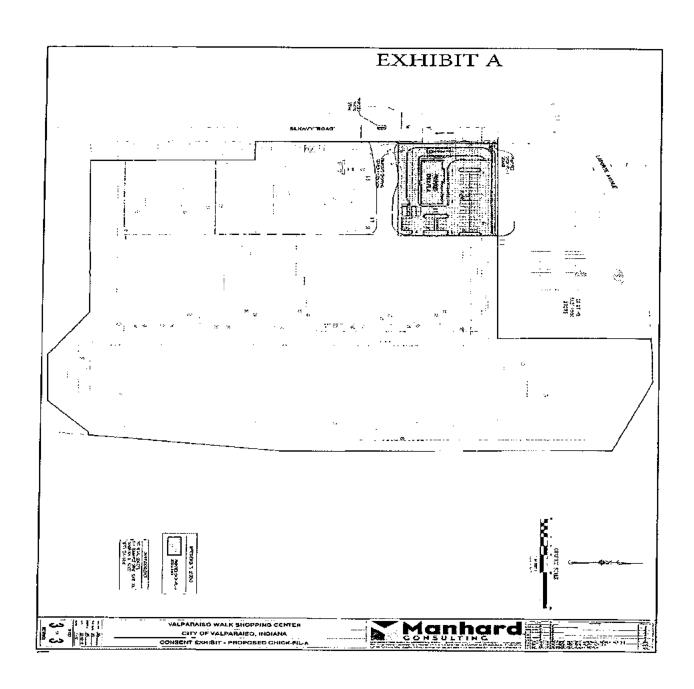

In the event that the IRC desire to reconfigure the ring road, or any portion thereof, which is subject to the rights of Aldi hereunder, the ingress and egress easement on, over and across the ring road located on the IRC's Parcel shall be terminated and extinguished and automatically reestablished and granted as to the reconfigured roadway system upon the IRC's Parcel; provided that (a) the reconfiguration shall not materially interfere with Aldi's access to Silhavy Road as existing at the time that this instrument is placed in the public records of the Recorder of Porter County, Indiana; and (b) the reconfiguration or redesign of the ring road does not alter the ring road or roadway currently established in the Easement Parcel, except as expressly requested by the City of Valparaiso. Menard, its successors, assigns and during any applicable tenancy, its tenants and subtenants do hereby grant and convey a nonexclusive perpetual common right and easement for ingress and egress together with the full and free right for Aldi, or its successors and assigns, invitees, vendors or licensees in common with all others having like right, at all times hereafter with or without automobile or other vehicles (including semi-trucks for deliveries) or on foot, for the purpose of ingress and egress to and from the Aldi Parcel or any portion thereof and to pass and repass on, over and across the ring road located on the Menard Parcel and depicted on the attached Exhibit A attached hereto and incorporated herein by reference. - 6. Maintenance. IRC, or the then owner of the Easement Parcel, shall maintain, repair, and clean the areas of ingress and egress located within the Easement Parcel (hereinafter referred to as "Maintenance"). Maintenance shall include but not be limited to the following:
 - a. Maintaining and replacing the asphalt surfaces in a level, smooth and evenly covered condition with the type of surfacing material originally installed or such substitute as shall in all respects be equal or superior in quality, use or durability.
 - b. Removing ice, snow, papers, debris, filth and refuse, as soon as practically possible, and sweeping to the extent reasonably necessary to keep it in a clean and orderly condition.
 - c. Placing, keeping in repair and replacing any necessary appropriate directional signs, markers and lines.

7. Cost of Maintenance.

- a. All costs and expenses in connection with the Maintenance (including snow plowing) of the Easement Parcel and the ring road shall be allocated and shall be the responsibility of the owners of the respective parcels benefitted by the Easement Parcel and ring road in the following percentages:
 - i. IRC Parcel, seventy percent (85%)

- ii. Aldi Parcel, fifteen percent (15%)
- b. The benefitted owners of each parcel shall be billed in an amount yearly for their pro rata share (based on the above percentages) of all expenses incurred by IRC in performing the Maintenance with the billing date being the first day of January or determined by IRC. The proportionate share of the total Maintenance expenses to be borne by each parcel owner for any year shall be paid to IRC within thirty (30) days after receipt of a billing, together with copies of such documents as may reasonably be required to substitute the billing.
- c. In addition to the cost and expenses incurred by IRC in performing Maintenance, each parcel owner shall pay to IRC an additional ten percent (10%) as an administration fee.
- 8. <u>Barriers and Obstructions</u>. There shall be no structures, barriers or obstructions permitted within the Easement Parcel. Notwithstanding the preceding sentence, temporary barriers may be put in place as reasonably necessary in the event of an emergency, or to perform maintenance within the Easement Parcel.
- 9. Easements to Run with the Land. The easements granted, conveyed and created herein along with all covenants, promises and agreements shall run with the land and be binding upon and inure to the benefit of the parties hereto and their successors and assigns, and all persons holding under or through the parties hereto, their respective mortgagees (and any party claiming by, through or under such mortgagee and any purchaser at any foreclosure sale), lessees, sublessees and their employees, agents, customers, licensees and invitees.
- 10. Not a Public Dedication. Nothing contained in this instrument will be deemed to be a gift or dedication of any portion of the Easement Parcel to any third party or for the general public or for any public purpose whatsoever, it being the intention of the parties that this instrument will be strictly limited to and for the purpose expressed herein. However, the IRC may, at any time, dedicate the Easement Parcel to the appropriate local government having jurisdiction for the use, occupation and maintenance of the Easement Parcel as a public street. Upon the effective date of said dedication and acceptance thereof by the local government, the IRC's obligation of performing Maintenance shall be fully released.

11. Indemnification and Insurance.

a. The parties hereto each indemnify and save the other harmless from any and all liability, damage, expense, cause of action, suit, claim, and/or judgment arising from personal injury, death, or property damage and occurring on or from its own parcel, except if caused by the willful act or negligence of the other party.

- b. The parties each agree to indemnify and hold the other and the other's parcel harmless from liens or claims for work or labor done or to be done or for materials furnished or to be furnished with respect to its activities on its parcel. In the event any claims, action or lien is filed against either party in connection with another's activities, the first party shall furnish to the other a copy of any and all papers served or delivered to it in connection therewith and the other shall defend such claim or action, and, in the case of a lien filed against the parcel of the first party in connection therewith, the other shall cause such lien to be removed therefrom, by bonding or otherwise, within thirty (30) days after receiving notice from the first party of such lien.
- 12. Ownership of Easement Parcel. IRC represents and warrants that IRC is the holder of the fee simple title to the Easement Parcel and the Utility Parcel and that the Easement Parcel and Utility Parcel are not encumbered with any contract purchase, lease, mortgage, tenant farmer, or any other interest inconsistent with the grant of easements made herein.
- 13. <u>Severability</u>. If any clause, sentence, or other portion of the terms, conditions, covenants, and restrictions of this instrument becomes or is illegal, null, or void for any reason, or be held by any court of competent jurisdiction to be so, the remaining portions will remain in full force and effect.
- 14. <u>Title to Real Estate</u>. In accordance with Indiana Code 32-5-2-2, IRC is seized of the fee simple title to the Easement Parcel described herein by virtue of a deed placed of record in the Office of the Recorder of Porter County, Indiana on December 31, 2012 as Document No. 2012-033817.
- Entire Agreement. This Agreement, including all exhibits and appendices hereto, embodies the entire agreement and understanding of the parties hereto in respect of the transactions contemplated by this Agreement and supersedes all prior agreements, contracts, representations, warranties, promises, covenants, arrangements, communications, and understandings, oral or written, express or implied, between or among the parties with respect to the subject matter hereof, including, without limitation, the Original Agreement, which Original Agreement shall be deemed null and void, and of no further force or effect whatsoever following the date hereof.
