

**ORDINANCE NO.: 24-2018**

**AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, ADOPTING AN ADDENDUM TO ORDINANCE NO. 16-2018 ENTITLED "CITY OF VALPARAISO 2019 SALARY ORDINANCE"**

WHEREAS, on September 24, 2018, the Common Council of the City of Valparaiso, Indiana ("Common Council"), adopted Ordinance No. 16-2018 entitled "City of Valparaiso 2019 Salary Ordinance"; and

WHEREAS, Ordinance No. 16-2018 established the salaries and other compensation to be paid to the employees/elected officials/members of boards and commissions of the City of Valparaiso, Indiana ("City") in 2019; and

WHEREAS, following the Common Council's adoption of Ordinance No. 16-2018, it was discovered that the Ordinance did not include compensation to be paid to various part-time employees throughout the City as well as the Valparaiso Fire Department's Probationary Firefighters in 2019; and

WHEREAS, the Common Council is desirous of adopting an addendum to Ordinance No. 16-2018 in order to include the compensation to be paid to various part-time employees throughout the City as well as the Valparaiso Fire Department's Probationary Firefighters in 2019.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF VALPARAISO, INDIANA, THAT ORDINANCE NO. 16-2018 SHALL INCLUDE THE ADDENDUM ATTACHED.

BE IT ORDAINED THAT, if any portion of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, such decision shall not affect any other portion or provision of this Ordinance.


BE IT FURTHER ORDAINED THAT, all ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency. It is provided, however, that such repeal shall be only to the extent of such inconsistency, and in all other respects the ordinances or parts of ordinances are hereby ratified, re-established and confirmed.

This Ordinance shall be full force and effect from and after its adoption and the procedures required by law.


